## Notification of transactions of directors/persons discharging managerial responsibilities and connected persons

Hrvatski Telekom d.d. ("HT d.d." or "the Company") hereby notifies that on 21 March 2014 the Raiffeisen Mandatory Pension Fund Management Company d.d. informed the Company of dealings in HT d.d. shares. This notification is made because Mr. Damir Grbavac, an insider on the General Insider List of the Company and a Member of the Supervisory Board of HT d.d., also holds the position of President of the Management Board of the Raiffeisen Mandatory Pension Fund Management Company d.d., which is thereby considered a connected person.

The above stated connected person made the following transactions regarding HT d.d. shares in the name and on behalf of the Raiffeisen Mandatory Pension Fund:

- On 17 March 2014, 5,000 ordinary shares were acquired at an average price of HRK 163.892960 per ordinary share, representing 0.0061% of the Company's issued share capital.
- On 20 March 2014, 5,000 ordinary shares were acquired at an average price of HRK 165.109326 per ordinary share, representing 0.0061% of the Company's issued share capital.
- On 21 March 2014, 5,000 ordinary shares were acquired at an average price of HRK 165.507208 per ordinary share, representing 0.0061% of the Company's issued share capital.

Following these acquisitions, the Raiffeisen Mandatory Pension Fund holds 6,496,856 ordinary shares in the Company, representing 7.9338% of the Company's issued share capital and the same number of votes at the General Assembly of the Company.
